**円貨建:**当中間期末残高は58,991百万円となり前年同期比26,922百万円減少(△31%)した。

事業法人への証書貸付案件の期限前返済及び協調融資案件の債権譲渡が主な要因である。

**外貨建:**当中間期末残高は156,464百万円となり前年同期比89,913百万円減少(△36%)した。事業

法人への証書貸付案件の期限前返済及び船舶及び航空機関連リースの貸付の元本返済スケジュールによる返済が主な要因である。

**円貨建:**当中間期末残高は283,364百万円となり前年同期比72,231百万円増加(+34%)した。期中平残ベースでは261,071百万円となり前年同期比5,234百万円増加(+2%)した。末残の増加は関連会社からの円預金の増加が主な要因である。

**外貨建:**当中間期末残高は46,448百万円となり前年同期比30,394百万円減少(△40%)した。期中平残ベースでは44,877百万円となり前年同期比41,029百万円減少(△48%)した。末残の減少は居住者からの米ドル建預金の減少が主な要因である。

### 3) 輸出入為替の取扱状況

**輸出信用状接受高(日本国外からの積出し分を含む)**は、前年同期比ほぼ横ばいであった(当中間期 45 百万米ドル、前年同期 48 百万米ドル)。依然継続する新型コロナの影響でアジア向けの輸出は回復がみられず前年同期比 54%減となった。一方、中南米向けの自動車輸出は前年同期比 5%増加した。

**信用状付輸出手形取扱高(日本国外からの積出し分を含む)**は、前年同期比 43%減となった。(当中間期 35 百万米ドル、前年同期 62 百万米ドル)。商社等顧客からの直接持込の減少(前年同期比 68%減)が要因である。この影響によりアジア向けの輸出の減少(前年同期比 85%減)が顕著となる。中南米地域向けの自動車輸出は前年同期比 30%減であった。

#### 4) 損益の状況

資金運用収益 当中間期資金運用収益は1,830百万円(前年同期比 $\Delta$ 1,855百万円、 $\Delta$ 50.34%)となった。貸出金利息が1,868百万円(前年同期比 $\Delta$ 1,762百万円、 $\Delta$ 48.54%)、買現先利息が $\Delta$ 344百万円(前年同期比+46百万円、+11.91%)、および本支店為替尻受取利息が $\Delta$ 44百万円(前年同期比 $\Delta$ 126百万円、 $\Delta$ 154.22%)となったこと等による。

資金調達費用 当中間期資金調達費用は313百万円(前年同期比 $\Delta$ 2,485百万円、 $\Delta$ 88.81%)となった。預金利息が3百万円(前年同期比 $\Delta$ 201百万円、 $\Delta$ 98.43%)、売現先利息が $\Delta$ 258百万円(前年同期比+76百万円、+22.80%)、および本支店為替尻支払利息が568百万円(前年同期比 $\Delta$ 2,359百万円、 $\Delta$ 80.59%)となったこと等による。

資金利益・損失 資金調達収益の減少を上回る資金運用費用の減少により、1,517百万円(前年同期比+629百万円、+70.98%)の資金利益となった。

役務取引等収益・費用 送金ビジネスによる受入為替手数料が753百万円(前年同期比+101百万円、+15.60%)となり、その他の受入手数料が546百万円(前年同期比 $\Delta$ 415百万円、 $\Delta$ 43.19%)となったことから、役務取引等収益は1,300百万円(前年同期比 $\Delta$ 313百万円、 $\Delta$ 19.45%)となった。役務取引等費用439百万円(前年同期比 $\Delta$ 187百万円、 $\Delta$ 29.88%)を差し引いた役務取引等利益は861百万円(前年同期比 $\Delta$ 126百万円、 $\Delta$ 12.83%)となった。

特定取引収益・費用 特定取引利益は、0百万円(前年同期比+0百万円、+100.00%)となった。

その他業務収益・費用 外国為替売買益は617百万円(前年同期比 $\Delta$ 2,017百万円、 $\Delta$ 76.56%)となり、その他業務利益は、605百万円(前年同期比 $\Delta$ 1,940百万円、 $\Delta$ 76.20%)となった。

営業経費 人件費は625百万円(前年同期比+35百万円、+5.95%)、物件費は1,774百万円(前年同期比+148百万円、+9.12%)となり、営業経費は2,431百万円(前年同期比+113百万円、+4.91%)となった。

経常利益・当中間期純利益 上記より、経常収益は3,757百万円(前年同期比 $\Delta$ 4,092百万円、 $\Delta$ 52.13%)、経常費用は3,205百万円(前年同期比 $\Delta$ 2,541百万円、 $\Delta$ 44.22%)となり、その結果、経常利益は552百万円(前年同期比 $\Delta$ 1,551百万円、 $\Delta$ 73.74%)となった。また法人税等108百万円を差し引いた当中間期純利益は443百万円(前年同期比 $\Delta$ 958百万円、 $\Delta$ 68.37%)となった。

## 2020年12月期の業績の概要

バンク・オブ・アメリカ・エヌ・エイの2020年12月期の受取利息は、貸出金及びリース金融に対する利息及び手数料を中心として46,439百万ドルを計上し、支払利息控除後の正味受取利息は43,753百万ドルの収益となった。利息外収益は、サービス手数料等を中心として23,521百万ドルとなり、正味受取利息と合わせた収益合計は支払利息控除67,274百万ドルの収益となった。一方、貸倒引当金繰入額、人件費を中心とした利息外費用を、それぞれ10,607百万ドル、39,051百万ドル計上した結果、税引前当期純利益は17,596百万ドルとなり、法人所得税控除後の当期純利益は14,298百万ドルの利益となった(対前期比12,458百万ドルの減益)。

バンク・オブ・アメリカ・エヌ・エイの2020年12月期末の資産合計は、9,205億ドルの貸出金及びリース金融残高を中心として2兆2,588億ドルとなった(対前期末比4,058億ドルの増加)。同期末の負債残高は、1兆9,064億ドルの預金を中心として2兆402億ドルとなった(対前期末比3,993億ドルの増加)。同期末の株主持分合計は、2,186億ドルとなった。
